Palm Beach County Emergency Order #3 Amendment Directing Safer at Home

Palm Beach County [Order 2020-003a](#), became effective today, March 30, 2020, at 12:01 a.m. The order STRONGLY URGES residents to stay home or at their place of residence, except to obtain necessary services and supplies as outlined in [Section 7 a-e](#) of the Order.

Palm Beach County COVID-19 Testing Site

Beginning tomorrow (4/1/) at 8 a.m., a medical support team will begin staffing the drive-thru test site in West Palm Beach. Appointments are scheduled for Tuesday, Wednesday and Thursday for patients who met the CDC screening criteria.

The Health Care District plans to reopen the COVID-19 Screening Hotline tomorrow morning (4/1) to continue scheduling appointments as more tests become available.

The number to call is 561-642-1000. Review the [CDC Guidelines](#) for COVID-19 testing.

On-site testing (swab sample collection) will begin on Tuesday, March 31st at the FITTEAM Ballpark of the Palm Beaches. **Pre-approval and appointments are required.**
