

RESOLUTION 13-21

A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF TEQUESTA, FLORIDA, ADOPTING A SUPPLEMENTAL APPROPRIATION TO THE BUILDING FUND #101 BUDGET FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2021; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, there are available for appropriation revenues or unappropriated fund balance in excess of those originally estimated in the Building Fund's budget for Fiscal Year 2020/2021;

WHEREAS, the Building Department is requesting an increase in its budget to provide additional funding to cover capital outlay expenditures in connection with its operations;

WHEREAS, the Fiscal Year 2020/2021 Building Fund Budget will be amended as specified in the attached "Exhibit A";

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF TEQUESTA, PALM BEACH COUNTY, FLORIDA, AS FOLLOWS:

Section 1: Resolution 13-21, amending and increasing the Fiscal Year 2020/2021 Building Fund Budget to recognize additional building permit revenues and by appropriating funds to provide additional funding for capital outlay expenditures;

Section 2: This Resolution shall become effective immediately upon passage.
